# What is Stormwater?

- Stormwater is rainwater that doesn't soak into the ground but runs off into waterways.
- Stormwater doesn't usually flow into any type of wastewater treatment system, it flows into our storm drainage system which then ends up into local streams, creeks, rivers and lakes.

# What is an Illicit Discharge?

 Any discharge to the storm sewer system that is not made entirely of stormwater

### Why Should You Care?

- In Florida City we use our water ways and ground water for recreation and as a source of drinking water.
- The City of Florida City is required to prevent pollutants from entering the storm sewer system.

# What Can You Do?

- Residents can help prevent stormwater pollution by:
- Preventing pollutants from being dumped or spilled into the storm sewer system (this includes driveways, sidewalks, streets, storm drains)
- Reporting pollution or questionable discharges to the storm sewer system or local waterways.



# Best Practices for Preventing Pollution

- Store and handle materials safely
- Clean up spills properly using dry methods
- Never dump or wash out items down or near a storm drain
- Blow or sweep fertilizer back onto the grass if it gets onto paved areas
- Don't blow leaves into the street
- Wash your car or outdoor equipment where it can flow to a gravel or grassy area instead of a street







### Recognizing Stormwater Pollution

Warning signs may include presence of the unusual:

- Color
- Odor
- Turbidity
- Floatable liquids and solids

Examples of What to Report *Unusual Odor* 



- Some odors are an immediate indicator of pollution
- Sewage, gasoline, and chemical odors should always be reported

Odor	Causes
Rotten eggs/hydrogen sulfide	Raw sewage, decomposing organic matter, lack of oxygen
Sharp, pungent odor	Chemicals or pesticides
Gasoline, petroleum	Industrial discharge, illegal dumping of waste, wastewater.
